## Regulations

The Swiss campsite owners hope that the following regulations will help make your stay in Switzerland pleasant and enjoyable.

### General obligatory regulations on Swiss campsites

- Validity** Those staying on the campsite should be familiar with and accept these regulations. The management can take precautions to keep the peace, order and cleanliness and can also sue those who cause damage. Guests not observing these rules may be forced to leave the campsite.
- Check-in** Every camper must check in before occupying a site and must also hand in an identity card. These rules also apply to day only visitors.
- Arrivals** The gates to the campsite will be closed between 21.00 and 09.00 h and during an eventual general quiet period from 12.00 to 15.00 h.
- Youngsters** under the age of 18 are only allowed onto sites when accompanied by an adult in charge or with written permission from their parents.
- Camping taxes** must be paid by request on arrival or, at the latest, before departure. Those departing after 11.00 h will be asked to pay an additional night.
- Emplacements** The camper has the right to exclusively use his allotted place. For use of other facilities, damages or dirt, charges may be raised.
- Motor vehicles** should only be used on arrival and departure from the camp. Site excursions are not allowed. The speed limit is 10 km/h (walking pace). All traffic is forbidden between 22.00 and 06.00 h.
- Installations** must only be used in the appropriate way. Water must be poured down to the appropriate drains and should never be poured down to the rainwater drains or simply onto the ground. Buckets must be placed under caravans and emptied regularly. Vehicles should only be cleaned on the specially indicated places (if existing at all). Sanitary installations should be left spotlessly clean. Water should not be wasted. Children under six are only allowed to use sanitary blocks under supervision.
- Pets** (if admitted at all) must be kept on a short lead or in a cage. The owner is responsible for them and their hygiene. Pets must never be taken into sanitary blocks, onto play and rest areas or on the beach. They should never be left alone and must not be allowed to disturb the neighbourhood. They must do their business on the indicated areas or outside the campsite and the owner must remove any mess immediately.
- Washing** must only be dried in the appropriate places or hung inside tents or caravans. Washing lines outside tents and caravans can be the cause of considerable danger.
- Quiet periods** from 22.00 until 07.00 h and eventually from 12.00 until 15.00 h must be observed. During these hours the staff should only be required in emergencies. Noise and all types of music should not disturb others and are forbidden after 22.00 h. During the summer and on special occasions the campsite management is entitled to delay the beginning of the quiet period.
- Games** Dangerous games are not to be played between the caravans and tents. If play grounds exist, the players must keep to them.
- Fires and fireworks** can only be held with the explicit permission of the campsite management on the specially indicated places.
- Liability/damage** The causer is liable for all damages. The campsite management rejects any liability for accidents, thefts, damage caused through use of defective or unsuitable equipment and also damage caused by acts of God. For damage caused by acts of God the guest is responsible for his own insurance.
